



Funded by Horizon Europe (GA No. 101147328), the **ReSKILLING project** brings together 20 partners to **support workers**, **businesses**, **academia**, **communities**, **and policymakers** in navigating the rapid shift to CCAM technologies. Whether you're a worker in the field, technician, trainer, mobility planner, researcher, policy expert, or simply

curious to learn more about a smarter, fairer, and human-centred mobility future for Europe, this Newsletter will keep you updated with our latest findings and developments.

You will discover new business models or reskilling strategies tailored to the evolving sector, hear about emerging curricula grounded in real-world CCAM and automation scenarios, and gain a better understanding on how to respond to a rapidly transforming transport labour market.

This affiliation underlines the importance of **skills and social innovation** as key pillars of a successful transition towards a competitive, sustainable, and human-centered CCAM mobility.

And there is more: the European Commission's new Action Plan on the Future of the Automotive Industry directly reinforces the ReSKILLING goals. Outlining a roadmap to strengthen the EU's competitiveness in the face of rapid technological transformation, the plan builds upon partnerships like <a href="Mailto:2Zero">2Zero</a> and <a href="CCAM Association">CCAM Association</a> and sets the baseline for creating a European Connected and Autonomous Vehicle Alliance.

The Action Plan focuses on developing cross-border testbeds, next-gen software platforms, and Al solutions, but also recognises the critical role of skills in enabling a fair and inclusive transition for European workers. Hence, the ReSKILLING mission closely aligns with the Action Plan's priorities, particularly in supporting workforce readiness and addressing the skills gap.
